


## Tsilhqot'in Aboriginal Title Case

- On June 26, 2014, the Supreme Court of Canada rendered a historic judgement in the Tsilhqot'in Nation's Aboriginal title case.
- The court declared Aboriginal Title to approximately
  1900 square kms
- First time in Canadian history
- The court rejected the 'postage stamp' view of Aboriginal Title once and for all




#### Chilcotin War

The Chilcotin War, the Chilcotin Uprising or the Bute Inlet Massacre was a confrontation in 1864 between members of the Tsilhqot'in people in British Columbia and white road construction workers. Fourteen men employed by Alfred Waddington in the building of a road from Bute Inlet were killed, as well as a number of men with a pack-train near Anahim Lake and a settler at Puntzi Lake.



## Mount Polley Mine Disaster

"Shortly after midnight on August 14, 2014, a major breach occurred at Mount Polly tailings storage facility. The failure of the dam was sudden, with no warning. It sent 25 million cubic metres of wastewater and mine waste solids into downstream waters, destroying or affecting over nine kilometres of aquatic and riparian habitats."

- This is why 'business as usual' can not continue.
- 123 Active mine tailings dams in BC. If things go unchanged, there will be 2 breaches every 10 years.

# Bill 41 – The Declaration on the Rights of Indigenous People's Act

- A new law to uphold Indigenous Rights in BC
- BC is one of the first jurisdictions in the world to implement UNDRIP
  - 1st all BC laws must line up with the Declaration
  - 2<sup>nd</sup> government is to develop an implementation action plan
  - 3r annual progress report will be developed
  - 4<sup>th</sup> provide for certain statutory decisions to be made jointly

- The Chilko River has approximately 1 million returning salmon every year
- Travel 805 kms to reach Chilko Lake from the ocean
